Electropathy System of Medicine - Reg.

Sir,

I am directed to refer to this Ministry's letter No.R-14015/3/88-Homoeo dated the 1st September, 1988 regarding constitution of Electropathy/Electro-homeopathy system of medicine Inquiry Committee to investigate the claims/merits of the Electropathy/Electro-homoeopathy System of Medicine for the purpose of its recognition as a new 5th system of medicine/treatment in India and to say that an assurance has been given by the Dy. Minister for Health & Family Welfare during discussion in the Lok Sabha on 22.2.91 on a private Member's bill for constitution of an Expert Committee to go into the recommendations of the Inquiry Committee set up during September, 1988 and to examine their feasibility before these could be implemented.

In pursuance of the said assurance by the Hon'ble Dy. Minister for Health & F.W., the Govt. of India are pleased to appoint an Expert Committee with immediate effect as under :-

Name of the Committee

The Committee shall be known as Expert Committee on Electropathy/Electro-homoeopathy system of medicine.

Composition

The Committee shall be composed of the following persons:-

Terms of Reference

The Committee shall have the following terms of reference :

1. Whether the Electropathy/Electro-homoeopathy System is a well established system of medicine.
2. Whether it is a prevalent system and it has a widespread network of practitioners who are practising in this system of medicine.
3. Whether sufficient literature is available.
4. Whether it can be taught in a recognised institution to produce doctors in this system of medicine.

Terms of the Committee

The Committee shall make recommendations to the Govt. on all or any of the matters specified in the terms of reference. The Committee shall submit its report to the Ministry within one month.

Miscellaneous

The Committee shall have powers to elicit information/data pertaining to the subject matter of the inquiry as it may decide from time to time.

2. The expenditure on TA/DA of the Chairman/Members of the Committee shall be met from out of the sanctioned budget grant of the respective sub-head from which their pay and allowances are drawn.

3. Expenditure on TA/DA, etc in respect of non-official members will be made as per instructions laid down under SR 190 as amended from time to time.

4. The Directorate General of Health Services shall provide the requisite secretarial assistance to the Committee.

These orders issue with the concurrence of the Integrated Finance Division of this Ministry vide his Dy. No. 2294/91-F.II dated 15.5.91.
